

Shippensburg Soccer Booster Club Minutes

February 1, 2020

Present: Rhonda Gladfelter, Jen Shuman, Becky Cramer, Jen Clough, Michelle Holtry & Katrina Dubbs

Call to order: 7:03 P.M.

December Officer Meeting Review: Rhonda noted that officers met in December for a brief meeting. Reviewed some of the topics touched on during that meeting.

Treasurer's Report: Becky noted that our current balance is \$7,739.51. There is also a balance of \$500.00 in savings at this time. Rhonda noted that the SASHS 2020 Senior Class is asking for a donation for Senior Night. It was agreed to send them \$50.00.

Introduction of New Officers: Katrina Dubbs was introduced as the new secretary for the booster club. She was elected during the December officers meeting.

Coaches Update: No reports; no coaches were in attendance in the meeting.

Off Season Activity Planning:

1. **Winter League** – boys winter league has been running and will continue to do so for a few more weeks. Katrina noted that Coach Powell did send out notification via the Remind app of a futsal tournament in Chambersburg on February 16 to any interested girls. There was at least 8 girls that were interested.
2. **Weight Room** - unknown usage
3. **Camp** – Becky and Rhonda will be handling the details regarding the boys' camp. They have 8 boys who want to attend, with 5 of them having paid their deposit. They have until the end of March to pay the deposit. Camp will be held July 10-13.

Girls camp – The Shippensburg University camp for the girls will actually be held at Gettysburg this year, so the girls will need to stay overnight for the camp. Camp is to be held July 19-22 (fair week). Rhonda plans to send out the information to families and will advise the coach that she is sending out the information.

Website: Rhonda encourages everyone to check out the soccer booster website. She hopes to engage the coaches to use the site to make announcements.

MS Season Planning: The meeting for the middle school spring season is **February 24/2020** and will be held at the high school. Packets are to be distributed at this meeting and returned to the booster club by **March 13, 2020**. Practice will begin on **March 2, 2020**. Coaches for the boys are Tim Carey and Bill Lloyd. Kelsey Harris is the girls' coach; no assistant coach at this time. **March 30, 2020** will be the first game of the season. We need to get the players packets prepared for the meeting. The packets should include:

- * welcome letter
- * sock order form
- * contact sheet
- * spirit wear form
- * snack order form (that will also ask about allergies). Snack bags will include a granola bar, cookies, chips, fruit snacks, fruit and Gatorade. Snack bag price was set at \$3.00 per game.
- * spring banquet form – Tentative banquet date is **Wednesday, May 20, 2020 @ 6:00 P.M. SASHS cafeteria**. Discussion was held and it was decided that the booster club will again provide the chicken for the meal and will also provide a sheet cake for dessert. Players will be asked to bring a hot or cold dish to the meal. Players and coaches are free; parents and guests will be charged \$5.00 per person.
- * Maplewood sandwich forms (see notes under Fundraising Planning)

Fundraising Planning: Discussion held about upcoming fundraising events, with the hope that more parents and players will be participating.

1. **March: Maplewood sandwiches** – It was decided to add the order forms for sandwiches to the welcome packets being handed out at the February 24 school meeting. Jen S. will check to see if we can add whoopee pies to the orders, per suggestion of Becky. Orders will need to be turned in by **March 27** and Rhonda will check to see if the church will be available for sorting and distributing of the sandwiches on **April 8, 2020**.
2. **Redemption BBQ dinner tickets** – tickets are to be sold from mid-April to mid-May. Forms for the tickets will be emailed on **April 22, 2020** and orders **and** money need to be returned to the booster club by **May 13, 2020**. The tickets will then be handed out to the players at the banquet to be tentatively held on **May 20, 2020**.

Further fundraising plans were tabled for the evening, including the Fair Stand in July, Smith's Chicken in September and Baked Goods in November. Jen S. did note that unlike last year, the Smith's Chicken sale will be held at Tractor Supply.

Fair Timeline: Rhonda still needs to update the timeline. Becky will be sending in the food handler license payment in March. In April, Jen S. will be handling the following:

- Order 4 – ¼ kegs (2 of root beer, 2 of birch beer) and blocks
- Request 1000 mild packets of Taco Bell sauce
- Request 1000 BBQ packets from Alfredos
- Request round tortilla chips from Utz and 250 packs of Doritos (Rhonda also to request from her source?)
- Check with Pepsi regarding water
- Request gift cards from BJ's (will be doing this multiple times) in order to purchase taco seasoning (Rhonda will get a donation letter to Jen for the requests)

Also in April, Becky will be ordering 200 pounds of beef and 72 gallons of broth for the potpie.
