

**Shippensburg Soccer Booster Club**  
**Meeting Minutes**  
**5/21/2012**

The meeting was called to order at 7:00pm by Joette Shetter.

**Secretary's Report:**

Minutes from 4/16/2012 presented by Carolyn Ritchie. Approved by Mary Eutzy; seconded by Shelly Shoemaker.

**Treasurer's Report:**

Presented by Shelly Shoemaker. Additions and deletions discussed. Mary Crouse moved that Treasurer's Report be approved as submitted. All were in favor.

**Business:**

Banquet discussion occurred next. Joette confirmed banquet will be held on Thursday, May 24<sup>th</sup> at 6pm. The senior gifts and coaches gifts have been purchased. Rocky brought a sample of the program that will be handed out. Robin to provide Mary E. with a program insert that will allow parents to provide contact information to the Booster Club thus allowing for better future communication. Was some discussion regarding charging a flat fee for anyone over 5 years old at future banquets, as it is apparent some parents are passing there kids off as younger in order to pay the cheaper price. Tabled until next year. Mary E. stated she be starting to set up the banquet around 4pm, and all were welcome to help.

Joette stated a few committee members had met at the fair booth on May 14<sup>th</sup> to check things out. She was happy to report there were no major issues noted. Biggest issue remains moving the hot water heaters. Joette stated Shawn Fry had expressed an interest in helping the Booster Club with booth repairs, and she was waiting for him to contact her with a good date and time. A refrigerator is still needed for the stand. Carolyn and Mary C. both indicated they probably had one to donate. Joette confirmed that 12 total day leaders were needed to be in charge, two each day of the fair. Committee members indicated their preferred days. Others to be solicited.

Joette stated she had received a schematic from Mr. Swartz detailing the placement of the desired soccer shed at the high school. Joette stated now a decision needed to be made regarding who will build the shed, what it will be constructed of and how it is to be painted. Once that information is decided, it will be added to the schematic and can then be presented to the Athletic Board. Mary E. stated she would get an estimate from a contractor she knows.

Joette stated she spoke with Matt Ulmer about the canopy that was purchased to shelter the player bench, as it has not yet been erected. He was unsure as to where it was at this point, but he believed it was in the barn. Shelly stated she would speak with Trainer Tom to see if he could assist in getting in back in the possession of the Booster Club.

Joette stated she has not yet met with the local businessman who offered to sponsor a soccer scoreboard. She asked that anyone who would be willing to step up and assist with this let her know.

Joette stated she had received a letter from the Senior All Night Party Committee asking if the Booster Club would like to donate any money toward the party. In exchange, credit would be given to the Booster Club in the brochure for the party. Carolyn moved that the Booster Club donate \$50 toward the party. Seconded by Mary C. All were in favor.
